Subject : Supply, Installation & Commissioning of Security arrangement of existing access control structure at Malad Hill Reservoir under AEWW(M)WS / North II division.

The Brihan Mumbai Municipal Corporation (BMC) invites e-tender on ~~Item Rate /~~ Percentage Rate Basis to appoint Bidder for the aforementioned work. BMC scheduled registered bidders in electrical /mechanical category of BMC class 'B' or above and with similar or higher class of public sector or Govt. or semi Govt. organization OR Registered bidders in public sector or Govt. or semi Govt. organization. The bidder should have executed minimum one single job of **Mechanical works** in BMC or government or semi government in the last Seven (7) years. Documentary proof of Work / performance certificate & plant capacities should be furnished for same. The bidders who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. **E.M.D** (Earnest Money Deposit) **will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.**

Bidding Process will comprise of THREE stages.

The bidder has to fill in online format and upload information regarding Tender Online.
