Sealed Expression of Interest (EOI) are hereby invited from experienced and eligible Voluntary Organizations / Non-Governmental Organizations (NGOs) for the following work under the jurisdiction of C Ward of Brihanmumbai Municipal Corporation.

1. Period for Collection of EOI / Letter of Intent

The EOI / Letter of Intent documents shall be collected from the office of the undersigned on payment of the prescribed EMD of ₹14,300/- and Tender Fee of ₹1,600/- + 18% GST (₹1,888/- inclusive of GST) from **10/09/2026 to 18/09/2026 between 11.00 a.m. and 4.00 p.m.**

2. Submission of EOI / Letter of Intent

The duly filled and signed EOI / Letter of Intent along with all requisite documents shall be submitted to the office of the undersigned on or before **21/09/2026 up to 4.00 p.m.**

3. Preference in Selection

Preference shall be given to the applicants having relevant experience of execution of similar manpower supply / contractual labour works in C Ward.

In the absence of eligible applicants having such experience in C Ward, second preference shall be given to applicants having experience of similar works in Zone-I of Brihanmumbai Municipal Corporation.

4. Eligibility

The participating NGO / Voluntary Organization shall possess valid registration and statutory documents as applicable and shall have adequate experience and capacity to provide contractual manpower for the proposed work.

The applicant shall submit documentary evidence in support of its experience, particularly experience of similar work executed in C Ward / Zone-I.

5. General Conditions

- Submission of EOI does not confer any right on the applicant for award of work.
- The Corporation reserves the right to accept or reject any or all EOIs without assigning any reason.
- The successful applicant shall comply with all applicable statutory provisions relating to contractual manpower, minimum wages, labour laws, EPF, ESIC, GST and other applicable statutory requirements.
- The manpower shall be provided as per the requirement and directions of the concerned Engineer of C Ward.
- The NGO shall be responsible for payment of wages and all statutory benefits to the manpower deployed by it.
- The detailed terms and conditions shall be as contained in the EOI document issued by the office.
- Any amendment/corrigendum, if required, shall be displayed on the office notice board / prescribed BMC platform.
