The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' Act 2013 , the contractors registered with the Brihanmumbai Municipal Corporation(BMC) in **Class VI and above as per new registration 2015 & 2016** and Those having equivalent or more work experience from Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that the contractors who are not registered with BMC will have to apply for registering their firm within three months from date of issue of work order failing which their Bid security i.e. EMD (Earnest Money Deposit) will be forfeited/ recovered and penalty of 0.1% of contract cost OR Rs.10,000/-whichever is more will be recovered / deducted from the Contractors payment / bill by the executing department.
