**Sub - Corrigendum for Extension for SUPPLY OF X-RAY FILMS, CHEMICALS, E. C. G. ROLLS, MATERIELS ETC. AS PER SCHEDULE NO. IV OF 2023-25 (Part 2).

1) UPDATED (GENERAL INSTRUCTIONS TO THE TENDERERS) (Tender Manual Condition)

19. Tax :-

1. All the rates quoted by the tenderer should be inclusive of all taxes, i.e G.S.T. and other state levies/cess which are not subsumed under GST. The tenderer shall quote the rates inclusive of all taxes & duties clearly & understood that BMC will not bear any additional liability towards payments of any Taxes & duties.
2. If the services to be provided by the Tenderer falls under Reverse Charge Mechanism, the price quoted shall be exclusive of GST, however same shall be inclusive of taxes /Duties/Cess other than GST, if any.
3. Rates accepted by BMC shall hold good till completion of work and no additional individual claim shall be admissible on account of fluctuations in market rates; increase in taxes /any other levies/tolls etc. except that payment recovery for overall market situation shall be made as per price variation and if there is any subsequent change (after submission of bid) in rate of GST applicable on the work/services to be executed as per tender, i.e. any increase will be reimbursed by BMC whereas any reduction in the rate of GST shall be passed on to BMC as per the provisions of the GST act.
4. As per the provision of Chapter XXI-Miscellaneous section 171(1) of GST Act, 2017 governing 'Anti-Profitteering Measure' (APM), 'any reduction in rate of tax on any supply of goods and services or the benefit of input tax credit shall be passed on to the recipient by way of commensurate reduction in prices'.

Accordingly, the Tenderer should pass on complete benefit accruing to him on account of reduced tax rate or additional input tax credit to BMC.

Further, all the provisions of GST Act will be applicable to the tender

2) UPDATED SAMPLE SUBMISSION & VERIFICATION CHARGES (Tender Manual Condition)

4. Testing/ verification of the samples of the lowest responsive tenderers will be carried out by BMC & if not found satisfactory, in such case his offer though lowest will not be considered & penalty/ action as applicable for inferior supply as mentioned in the tender document will be taken. **The successful tenderer shall have to pay Rs.4,770 /- verification/Testing charges per item at the time of receiving Acceptance Letter. These charges are subject to increase @ 10% after 01/04/2024 & will have to paid in deviation of the nearest Rs. 10/-.**
