E-TENDER NOTICE

Subject: Reconstruction of RCC chambers for various dia BFVs in City water network under A.E (M) WW- City.

The Brihanmumbai Municipal Corporation (BMC) invites online e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies act 2013, the contractors registered with the Brihanmumbai Municipal Corporation (BMC) in **“Civil Category for Class IV(A) and Above as per new registration rules”** and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, and shall establish office in Mumbai Metropolitan Region otherwise their Bid Security i.e. **E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.** Bidding Process will comprise of THREE stages.

The forms of Tender documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download Tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding Tender Online. Also, he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.

For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the e-tendering process and obtain login credentials to participate in the online Tender process. The applicant has to pay Scrutiny Fee of Rs. 14,160.00 (Rs.12,000 + 18% GST, i.e. 2,160.00). (Circular no. CA/FRG/03 dated 11.05.2023). The Scrutiny Fee shall be paid after opening of Packets 'A' and 'B' and before opening of Packet 'C' in any CFC of BMC by challan(Circular no. CA/FRG/10 dated 19.10.2023).

While submitting duly filled tender document through <https://mahatenders.gov.in> bidder needs to pay EMD amounting to Rs.89,210.00 out of which bidder has to pay 10% EMD online i.e. **Rs.8,921.00 (Rupees Eight Thousand Nine Hundred Twenty One only.)** & remaining 90% of EMD **Rs. 80,289.00 (Rupees Eighty Thousand Two Hundred Eighty Nine only)** in the form of Demand Draft(DD) payable to Brihanmumbai Municipal Corporation (BMC) physically to Head clerk, Water Works (Civil) Maint. DD for part EMD shall be submitted to the Head clerk, Water Works (Civil) Maint. on the next working day of bid submission and before opening of Packet 'A'. EMD is refundable in accordance to the relevant clause of bid document, excepting the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways and in form of Demand Draft as mentioned above while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit in the both forms as mentioned above. The e-tender is available one-Tendering website <https://mahatenders.gov.in>. as mentioned in the Header Data of the tender.

- The Applicant has to prepare & submit Tender Documents Online on or before last date of submission as mentioned in tender notice.
