#### **E-TENDER NOTICE**

**Subject: The work of Supply, Installation, Commissioning of Trash Boom attached with pontoon mounted conveyor system to collect, remove and disposal of floating material from various nallas in Western Suburb in Mumbai, including O & M of 5 years.**

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013 , the contractors registered with the Brihanmumbai Municipal Corporation, (BMC) under category Mechanical /Electrical , **Class 'A' as per new registration rules, 2016 (excluding those who are blacklisted or against whom FIR has been filed)** or those having equivalent or more work experience from the contractors/firms registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three month's time period from the award of contract, failing which there EMD (bid security) will be forfeited and a penalty of 0.1% of contract cost or Rs. 10000 whichever is more will be recovered/ deducted from the contractors payment/bill by the executing department. Bidding Process will comprise of THREE stages.
