The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013 , the contractors registered with the Brihanmumbai Municipal Corporation (BMC) under Mechanical/Electrical category Class,,A'(as per registration rules 2015)and Class,,A'(as per new registration rules, 2016) and from the contractors/firms registered in Central or State Government/Semi Govt. The subject work is related to the work of Providing System Engineerand support services in the sections of SWD department. Hence the class registration with BMC of such a service provider shall be waved off. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three month's time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.

### **ELIGIBILITY CRITERIA**

### **A) Technical Capability:**

a) The tenderer in their own name shall have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt./Pvt. & Public Sector Organizations during **last seven (7) years** ending last day of month previous to the one in which bids are invited as a Prime Contractor (or as a nominated Sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

**1) Three similar completed works each of value not less than Rs.356400 /-**

**OR**

**2) Two similar completed works each of value not less than Rs.445500/-**

**OR**

**3) One similar completed work of value equal and or not less than Rs.712700/-**

The Bidder shall submit the certificate of satisfactory completion of work from the user Department of BMC / Semi Govt. / Govt. / Pvt./Public sector organization, failing which their offer shall be treated as non-responsive and their Packet 'C' shall not be opened.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

### **B) Financial Capacity:**

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to or minimum **Rs.534500/-** for last 3 financial years. To ascertain this, tenderer(s) shall furnish /upload the financial statement (Audited balance sheet) duly certified by Chartered Accountant. The turnover can be enhanced by 10% every year to bring the present level.

### **C) Similar Experience:**

For assessing the technical capacity in Work of Providing System Engineer and support services in the sections of SWD department similar work shall mean, Providing IT assistance Services along with development and maintenance of MIS and GIS application in BMC / Semi Govt. / Govt./ Pvt. / Public Sector organizations
