Subject: Tender for "Providing the services of installation and comprehensive maintenance of IOT devices on dewatering pumps on hire basis for the section of Dy. Chief Engineer (O&M) S.W.D. for 3 Years."

The Municipal Corporation of Greater Mumbai (MCGM) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with the Municipal Corporation of Greater Mumbai, (MCGM) under Mechanical/Electrical Category (class 'A' as per new registration rules 2016) or under Civil Category (class 'II' as per new registration rules 2016) and from the contractors/firms registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with MCGM will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.

In terms of the **3 stage system** of e-tendering, a Bidder will be required to deposit, along with its Bid, an Earnest Money Deposit of (the "EMD"), refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit.

The bidder shall pay the EMD amount through payment gateways of GoM on URL <https://mahatender.gov.in>. The bidders shall upload the screen shot of receipt of online payment.

Packet 'A', 'B' & 'C' shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of **Dy. Chief Engineer(O&M)S.W.D.** The Packet 'C' shall be opened if bids submission in Packet 'A' & 'B' satisfies/includes all the requirements and same are found acceptable to the Authority.
