This is an E-Tender notice. The Brihanmumbai Municipal Corporation invites the following online tenders. The e-Tender copy can be downloaded from mahatenders portal (<https://mahatenders.gov.in>) under “e-procurement” section.

All interested bidders i.e. fulfilling the specified eligibility criteria, whether already registered or not registered in BMC, are mandated to get registered with BMC for e-tendering process, Login Credentials to participate in the online bidding process on the above-mentioned portal under “e-procurement”.

For registration, enrollment for digital signature certificate & user manual, please refer to respective links provided in e-tendering tab on BMC website. The bidders can get digital signature from any one of the Certifying Authorities (CA’s) licensed by the controller of Certifying Authorities namely Safes crypt, IDRBT, National Informatics Centre, TCS, Customs, MTNL, GNFC and e-Mudhra CA.

BMC has opened a help desk at the LTMG Hospital Assistant Engg (M&E)’s office to help the bidders in this regard.

The technical and commercial bids shall be submitted online up to the Bid End Date & Time mentioned below.

**Eligibility Criteria for bid No.1 is as follows:**

1. Class B in Mechanical & Electrical category as per new registration rules 2016.  
2. The tenderer(s) in their own name should have satisfactorily executed the work of similar nature MCGM/Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

- a) Three similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 3.98 Lakh                      OR
  - b) Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 4.98 Lakh
- OR
- c) One similar completed work of value equal & or not less than the value equal to estimated cost put to tender i.e. Rs. 7.96 Lakh

The Material supplied should be as per M&E USOR-2023 approved make and technical specifications. Bidder should have to submit sample material to the office A.E (M&E) LTMG hospital, one day prior to the due date. Without the samples the tender shall be rejected out-rightly & will remain unopened.

For assessing the technical capacity of Regular, Routine and Maintenance works; similar work shall mean, satisfactorily completed supply of electrical material. (Performance certificate from user shall be attached with quotations.)

Documents of compliance of above criteria shall be uploaded during the submission of the tender.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.

**Eligibility Criteria for bid No.2 is as follows:**

1. Class B in Mechanical & Electrical category as per new registration rules 2016.  
2. The tenderer(s) in their own name should have satisfactorily executed the work of similar nature MCGM/Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

- a) Three similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs.4.11 Lac                      OR
  - b) Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e Rs.5.14 Lac
- OR
- c) One similar completed work of value equal & or not less than the value equal to estimated Cost put to tender i.e. Rs.8.23 Lac

The tenderer must have experience of SITC/ AMC/CMC of Hospital equipment's, failing which the offer will be considered as Non –responsive offer.

In this case similar work shall mean the satisfactorily completed CMC of Hospital Equipment work in hospitals MCGM / Semi Govt. /Govt. & Public Sector Organization.

1) The bidder shall submit a sample of Spiral Wounded Ultra Filtration (UF) Membrane as per technical specifications along with testing certificate from NABL accredited laboratories within three days after opening of Packet "A" and Packet "B", failing to which the offer of that bidder shall be treated as non- responsive.

2) The bidder shall submit a sample of Domestic SS304 Ultra Violet (UV) Chamber as per technical specifications along with testing certificate from NABL accredited laboratories within three days after opening of Packet "A" and Packet "B", failing to which the offer of that bidder shall be treated as non-responsive.

The Tenderer shall note the following criteria towards their eligibility.
