

E-TENDER NOTICE

Subject:Supply of Spare parts required for Shinohara Machine installed at Printing department of Municipal Printing Press.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned work from contractors of repute, multi-disciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with the BrihanmumbaiMahanagarpalika, (BMC) Manufacturer or their authorised dealershaving experience of Supply of Spare parts for Four color offset Printing machinein the Central/State Government Organization/BMC/Reputed organisations except those who are blacklisted or against whom FIR has been filled or from the contractors /firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, The contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

Bidder should note that the Tender fee of Rs. 3,630 /- + 18 % GST will be payableimmediately after opening of Packet A & B in any of the Ward Citizens Facilitation Centers (CFCs)or will recover from EMD of concerned bidder as per Circular No. CA/FRG/09dt.04.10.2024.

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. 

A) Eligibility Criteria

1. For Regular, Routine and Maintenance works:

1.1 Technical Capacity

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature BMC /Semi Govt. /Govt. & Public Sector Organizations/ Reputed organisations during last Seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

a) Three similar completed works each of value not less than the value equal to Rs5,17,690/-

OR

b) Two similar completed works each of value not less than the value equal to Rs.6,47,112/-

OR

c) One similar completed work of value equal and or not less than the Rs.10,35,379/The value of executed works shall be brought to current costing level by enhancing
the actual value of work at compound rate of 10 % per annum; calculated from the
date of completion to last date of receipt of applications for tenders.

Technical capacity will be considered for Manufacturer or their authorised dealer.

1.2 Who Can Quote:

Only the Original Equipment Manufacturer (OEM), their authorized dealers and channel partners are qualified to fill and submit the tender. Only Manufacturers Authority certificate or channel partners authorized dealer certificate will be considered. Authority certificate submitted by dealers or sub dealers will not be considered. Such offers will be kept outright and shall be treated as Non responsive.

1.3 Similar Experience:

For assessing the technical capacity of Regular, Routine and Maintenance works; Similar work shall meanSupply of Spare parts for Four color offset Printing machine for any similar model.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properlycompleting the contract, inordinate delays in completion, litigation history, or financial failures etc.
