## **E-TENDER NOTICE**

**Subject: Biannual works contract for the works of Electrification, Rewiring, Public address system on Rent at F-South &G-South ward of BMC.**

The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned work from contractors of repute, multi-disciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered in Electrical with the Municipal Corporation of Greater Mumbai, (MCGM) with valid registration of **Class "C" and above** in Mechanical & Electrical as per registration rule 2015 & **Class "C" and above** in Mechanical & Electrical category as per new registration rules 2016 except those who are blacklisted or against whom FIR has been filled or from the contractors /firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings & having valid PWD's electrical contractors license, will be allowed subject to condition that, the contractors who are not registered with MCGM will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

Bidder should note that the Tender Scrutiny fee of Rs. 18,150/- + 18 % GST will be payable immediately after opening of Packet A & B in any of the Ward Citizens Facilitation Centers (CFCs) or will recover from EMD of concerned bidder as per Circular No. CA/FRG/03 dt. 11.05.2023.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (<http://mahatenders.gov.in>). The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of CPD Byculla.

ii) The forms of Tender documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download Tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding Tender Online. Also he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.

iii) For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the e-tendering process and obtain login credentials to participate in the online Tender process. The tenderer may quote for individual group or even for all groups. However, each tenderer will be allotted only one group considering the percentage quoted whichever is beneficial to the MCGM.

If the one vendor is selected for one zone and the same vendor is lowest for the another zone, then second lowest vendor should have to carry out the work for the quoted value of first lowest vendor. One vendor will be selected for one zone only, even if the vendor is lowest vendor for another zone. In this case, the vendor can't be claim for the zone as per work convenience. The BMC reserves the rights, to take suitable decision regarding the selection of vendor beneficial to BMC or to maintain the upholding justice and transparency.

In terms of the 3 stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an Earnest Money Deposit of Rs. 3,00,000/- (Three Lakhs only) (the "EMD"), refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-tender is available on BMC portal (<http://portal.BMC.gov.in>) as well as on NIC Portal <https://mahatenders.gov.in> as mentioned in the Header Data of the tender.

As per THREE Packet systems, the document for Packet A & B is to be uploaded by the bidder in vendors' document online in Packet A, B. Packet A, B & C shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of Ch.Eng.(M&E) MCGM Engineering Hub Bldg., 1st floor, Dr. E Moses road, Worli Naka, Worli, Mumbai 400 018. The Packet C shall be opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.

## **A) ELIGIBILITY CRITERIA FOR M&E WORKS**

### **1.1 Technical Capacity (For routine work)**

The tenderer (s) in their own name should have satisfactorily executed the work of similar nature BMC /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

- a) Three similar completed works each of value not less than the value equal to 20% of estimated cost (i.e. Rs. 10.00 Lakhs) i.e Rs. 2,00,000.

OR

- b) Two similar completed works each of value not less than the value equal to 25% of estimated cost (i.e. Rs. 10.00 lakhs) i.e Rs. 2,50,000.00

OR

- c) One similar completed work of value equal and or not less than the 40% of estimated cost (i.e.Rs. 10.00 lakhs) i.e Rs. 4, 00,000.00

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

### **Similar Experience:**

**For assessing the technical capacity of Regular, Routine and Maintenance works; Similar work shall mean,** that the contractor shall have executed works i.e. Mechanical & Electrical works of Electrification/Rewiring, and Replacement / Provision of water pump sets with allied electrical Works. **(Performance certificate from user shall be uploaded.)**

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached

along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
