Subject :- Supply of vehicle mounted mobile water misting units & sprinkle system on hire basis for the use on streets /by lanes/ small by lanes for suppression of air borne dust particles to mitigate air pollution -14 nos. [Group-A] and 12 nos. [Group-B].

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the afore mentioned work. The contractors shall be of repute, multi-disciplinary engineering organizations i.e., eminent firm, Proprietary / Partnership Firms / Private Limited Companies / Public Limited Companies / Companies registered under Indian companies' Act 2013. The contractors registered with the Brihanmumbai Municipal Corporation, (BMC) in appropriate Class in Mechanical and Electrical Engineering Discipline as per new registration and from the contractors / firms equivalent and superior classes registered in Central or State Government / Semi Govt. Organization / Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) shall be forfeited / recovered and an amount equal to Registration Fee of respective class shall be recovered as penalty.

Bidding Process will comprise of THREE stages.
