QUALIFICATION / ELIGIBILITY CRITERIA : The quotationer shall have BMC vendor registration. Firms dealing in line having similar experience during last 07 years in B.M.C. or any govt. / semi govt. organization. Bidder shall upload proof of competent authority's valid certificate.

Similar Experience: Similar experience means the completed work such as Tracing fault & Jointing of HT cables or Overhauling/Repairs/Testings of oil type transformers/HT switch gears in BMC / any govt. / semi govt. organization in last 7 years. The copy of the work order with number, date, contract period & cost of the work with work completion certificate shall be annexed by the e-quotationer while uploading the offer.

E-QUOTATION TENDER FEES: The e-quotationer shall make payment of e-quotation tender Fees of Rs. 363.00 + 18% GST (9% CGST + 9% SGST) on Mahatender portal..

2) The registered Municipal Contractors having standing deposit with BMC shall also have to pay Earnest Money Deposit for this e-quotation.

opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.
