

## EXPRESSION OF INTEREST

**Subject:** To invite Expression of Interest from vendors to **Supply, Installation, Testing and Commissioning of a High-Performance Liquid Chromatography (HPLC)** for the Department of Clinical Pharmacology, BYL Nair Hospital through CSR Fund received through PPF, BYL Nair Hospital from LIC Golden Jubilee Foundation

BYL Nair Hospital is a tertiary care referral hospital with 1623 beds. The Department of Clinical Pharmacology routinely performs the Therapeutic Drug Monitoring (TDM) drug analysis of anti-epileptic, anti-tubercular & anti-psychotic agents (phenytoin, phenobarbitone, valproate, carbamazepine, oxcarbamazepine, lamotrigine, levetiracetam, lacosamide, topiramate, zonisamide, isoniazid, rifampicin, ethambutol, pyrazinamide) and lithium as a part of the patient care service of the Department, for OPD and admitted patients, of our hospital as well as from other public municipal & Government hospitals (for example; Sion hospital, RN Cooper Hospital, JJ Hospital, GT & St. George hospital). For this purpose, we urgently require a High-Performance Liquid Chromatography (HPLC) as we are the only hospital that performs the wide range of TDM drugs which helps in better clinical management of the epileptic and tuberculosis patients.

For procurement of the High-Performance Liquid Chromatography (HPLC) for the Department of Clinical Pharmacology, it is proposed to invite "Expression of Interest (EOI)" from vendors to supply the same to BYLNair hospital.

To supply the required High-Performance Liquid Chromatography (HPLC), vendors should obtain **Application Form** from **Dean's Office on 02.02.2026 to 07.02.2026** and submit all required documents on or before **09.02.2026**, up to 1.00pm in the drop box in Dean Office, G building, Ground floor, BYL Nair Hospital. This will be a 2 stage EOI comprising of 2 packets; Packet A - relevant documents related to the technical specifications along with the duly filled Application form AND Packet B - Commercial documents (quotation in the prescribed format). Packet A will be opened on **11.02.2026** & **packet B will be opened on 13.02.2026** in the Dean's Office.
