Post Qualifying Criteria (Eligibility):

The Quotationer should specifically note the following post qualifying criteria (PQC) towards their eligibility. In case of firm dealing in line, the quotationer shall produce valid completion certificate or performance certificate in their own name for executing the work of similar nature in MCGM /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years.

For assessing the technical capacity of the subject work, similar work shall mean the completed or completed part of on-going 'works' in respect of "any IEC Work/ awareness campaigns/ setting up of exhibition stalls/ any beautification work/ designing of creative for IEC" for BMC / Semi Govt. / Govt. & Public Sector Organizations during last seven (7) years.
