Post Qualification Criteria:

The firms which have experience in providing "Online monitoring & support service for Govt. / Semi Govt. / ULBs are only eligible to quote for the subject work. Without documentary evidence (Completion Certificate or P.O. copy), in this regards, Quotation Notice shall be issued.

The blank quotation copies are available in the office of Executive Engineer (Sewerage Operation) Training & S.U.M.C at address mentioned below, between 11.00 a.m. to 4.30 p.m. on any working day, from Monday to Friday, of the month. The Challan for quotation cost shall be obtained from this office and paid at any CFC Centre. A copy of receipt of the payment shall be produced in this office upon which quotation document will be issued. The last date of issue of quotation forms will be upto the day of the due date i.e. 19.10.2022 up to 12.00 noon.

Earnest Money deposit (EMD):

The quotationer shall pay E.M.D. of Rs.3000/- by way of cash or Demand Draft drawn in favour of Municipal Corporation of Greater Mumbai payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (in case of quotation for supply), having revised Standing Deposit according to their class & category, are exempted from

payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
