POST QUALIFYING CRITERIA (ELIGIBILITY):

The Quotationer should specifically note the following post qualifying criteria towards their eligibility.

1. The quotationer shall be registered scrap dealer with BMC. Documentary proof of should be furnished for same. The copy of the same shall be uploaded with quotation documents.
2. If Quotationer failed to submit the documentary evidence of above, the offer will be treated as non-responsive.

The forms of quotation documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download quotation form, from the website mentioned above. The bidder has to fill in online format and upload information regarding quotation Online. Also, he has to download the quotation application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.

For purchasing the quotation documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the e-quotation process and obtain login credentials to participate in the online quotation process. The quotationer shall upload all the pages of the documents and on every relevant information / certificates / literatures etc., enclosed in packet 'A' & offer price in packet 'B'. - 1) **QUOTATION FEE:** The applicant has to pay Scrutiny Fee of **Rs. 3,630/- + 18 % GST (9 % CGST+ 9 % SGST)** (As per Circular No. CA/FRG/17 dtd 17/03/2025) online at Mahatender portal. The copy of the paid receipt shall be submitted along with the e-quotation.
- 2) **EARNEST MONEY DEPOSIT (EMD) :**

While submitting duly filled quotation document through <https://mahatenders.gov.in>, bidder needs to pay total EMD amounting to **Rs.24,600/-** online. The copy of the EMD paid original receipt shall be uploaded along with the other relevant documents on website, while uploading the quotation documents.

The quotation shall be out-rightly rejected if it is not accompanied by the Earnest Money Deposit in both form as mentioned above.

- The applicant has to prepare & submit quotation documents online on or before last date of submission as mentioned in quotation notice.
- The applicant should upload the documents in readable form. He should take trial of uploads by taking printout. The unreadable documents will be treated as null & void. The remaining documents will be evaluated. The decision of opening Authority regarding this will be binding to all the applicants.
- The Municipal Commissioner reserves the right to reject all or any of the e- quotation(s) without assigning any reasons at any stage. The information regarding above subject matter is available e-Tendering website <https://mahatenders.gov.in>.

Scrap dealers who are registered with B.M.C and have paid standing deposit are exempted from paying E.M.D. However they shall have to submit standing deposit receipt and relevant registration documents.

- 3) Quotation shall be opened on dates as mentioned in header data. The dates and time for submission and opening the quotation are as shown in the Header Data. If there are any changes in the dates the same will be displayed on the BMC Portal - <http://portal.mcgm.gov.in> as well as <https://mahatenders.gov.in>.

Quotationers are requested to submit and upload the quotations in time on or before the stipulated day so as to avoid rush at the closing hours. BMC will not be responsible for poor connectivity of network / internet services / connectivity of servers / snag in system / breakdown of network / or any other interruptions. If any online information uploaded but not received by quotation creator (BMC) within stipulated time limit, BMC will not be held responsible at any cost and such quotation cannot be validated. Any online intimation / information asked to be submitted by Quotationers / Contractors or sent to quotationers / Contractors, if not receiving or bounced back at the receiving end due to any problem in the server or connectivity, BMC will not be held responsible.

- 4) **Description of Scrap Materials :** Scrap Materials can be inspected during office hours by prior communication with A.E.(Malad)/ E.E.(S.O)W.S.Malad Ppg Stn. between 9.00 a.m. to 3.00 p.m., (Only 1 to maximum 2 persons will be allowed) except Saturday ,Sundays and Public Holidays.
- 5) The old Plant & Machinery items will be disposed off on lot basis on 'as it is & where it is basis'. The list of items is attached along with the quotation.
- 6) The successful quotationer shall have to **pay full amount of this offer plus applicable GST, TCS & any other taxes applicable** on receipt of written order of this office.
- 7) Should the original purchaser, whose offer has been accepted, wishes to take the delivery of the goods through a representative, he must authorise the representative by a letter of authority. Delivery by proxy will be at the purchaser's own responsibility and risk and no claim shall lie against BMC on any account whatsoever. If the delivery is taken by the wrong person.
- 8) The successful quotationer shall have to remove the scrap material after paying full amount of their offers within stipulated period and as per the conditions mentioned in the written order.
- 9) **Validity :** Offer shall remain firm for acceptance for the period of 90 days from the date of opening of quotation/tender.
- 10) **Delivery :** The scrap material should be removed within 30 days from the receipt of deposit of full amount subject to availability of concerned staff, i.e.; Store, Vigilance, Security, concerned Engineering staff. The delivery schedule will be mutually decided by concerned BMC staff & the successful quotationer.
- 11) **Penalty:**
 - i) The successful quotationer shall have to pay the full amount of their offer within 7 working days from the date of acceptance of offer by Cash/D.D. only, failing which penalty at the rate of 2% per day will be charged on the offer amount. Thereafter, if the Contractor fails to pay the offer amount with penalty if any, within 3 days, his offer will be cancelled & his name will be included in blacklist.
 - ii) The successful quotationer shall remove the scrap material within stipulated period of time, failing which the demurrage charges at the rate of 2 % per day will be charged on the balance cost of the material to be removed.
 - iii) If the successful quotationer fails to remove the scrap material, his standing deposit will be forfeited.
- 12) The successful quotationer shall have to engage their own labourers and vehicles for the removal of said scrap material.
- 13) The quotationer shall not withdraw his offer within the validity period. If he does so, the standing deposit paid will be absolutely forfeited by the BMC.
- 14) The quotationer shall attach the PAN documents with photograph of individual, owner, karta of HUDF, partners of firms and Directors duly certified by Gazetted Officer / Notarized by Notary or by any officers not below the rank of Executive Engineer of BMC. failing which the offers will be rejected outright.
- 15) Firms with common Proprietor / Partner or connected with one another either financially or as Principal and agent or an master and servant or with Proprietor / Partners closely related to each other such husband, wife, father/mother and minor son/daughter and brother/sister and minor brother/sister, shall not tender separately under different names for the same contract.
 - a. The firms as described in 15 have tendered separately under different names for the same contract, all such tender/s shall stand rejected and standing deposit of each such firm/establishment shall be

forfeited. In addition, such firms/ establishment shall be liable, at the discretion of the Municipal Commissioner, for further penal action including blacklisting.

- b. The closely related persons as in 15 have submitted separate tenders/quotations under different names of firms/establishment but with common address for such establishment/firms and or if such establishments/firms, though they have different addresses, are managed or governed by the same person/persons jointly or severally, such tenders shall be liable for action as in clause 15(a) including similar action against the firms/establishments concerned.
- c. If after reward of contract, it is found that the accepted quotation violated any of the clauses 15, 15(a), 15(b) or 15(c), the contract shall be liable for cancellation at any time during its currency in addition to penal action against the contractors as well as related firms/establishments.

16) The quotation may be considered incomplete, irregular and invalid unless it is signed by the proprietor, named managing partner or all partners or by the party or parties stating specifically their position and status at the following three places :-

- (a) The printed undertaking addressed to the Municipal Commissioner
- (b) The schedule of quantities and rates
- (c) The names and address of all the partners are given in the space provided therefore.

17) The Municipal Commissioner and the Brihanmumbai Municipal Corporation do not bind themselves to accept the highest or any offer and reserve the rights to reject all the quotations without giving any reason and thereafter sell the items individually or on lot basis.

18) All charges of dismantling, removing and loading of scrap material & labour charges, etc. should be borne by the successful quotationer.

19) i) The successful quotationer shall carry out the work in neat manner incorporated with safety procedure & practices for their workmen & equipment, etc. or Contractor will be held fully responsible for any damage or loss to Municipal Property or injury to Municipal employee or their worker, while execution of work.
 ii) Any damage made, while executing the work, to the Municipal property, civil structure & machinery shall have to be repaired free of cost by the successful Contractor at his own cost.

20) No variation will be allowed on ground such as mistake or misunderstanding, etc. after the quotation is submitted. The rate quoted shall be fix and no variation will be allowed on any account.

21) **Jurisdiction of Court** : In case of any claim, dispute or difference arising from respect of contract the cause of action thereof shall deemed to have arisen in Mumbai & all legal proceeding in respect of any such claim, dispute or difference shall be instituted in a competent court in the city of Mumbai only.

22) The offer inclusive of quotation notice form, the specifications, schedule of quantities and rates duly filled in and signed, shall be submitted failing which may render the offer liable for rejection.
